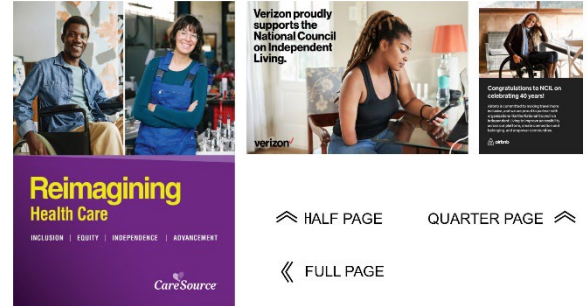


EXHIBIT SPACES

EXHIBITING TIMES

All exhibits will be open between the hours of 8:00 a.m. and 5:00 p.m. on Monday, 7/22, and Wednesday, 7/24. No exhibiting will occur on Tuesday, 7/23. There will be an Exhibit Fair on Wednesday, 7/24, from 10:15 a.m. to 12:00 p.m. During this time there will be no other activities scheduled for participants.

MOVE-OUT

Exhibitor move-out is currently scheduled for after 5:00 p.m. on Wednesday, 7/24. If you would like, Exhibitors can move-out at any point between Monday to Wednesday.
